

ORDINANCE NO. 365 - 2022

ORDINANCE OF THE TOWN OF ALEX, OKLAHOMA AMENDING CHAPTER 11-16 OF THE ALEX CODE OF ORDINANCES ASSOCIATED WITH TRAFFIC AND MUNICIPAL VIOLATIONS BUREAU ORDINANCE AND DECLARING AN EMERGENCY.

WHEREAS, the Town council of the Town of Alex, Oklahoma has determined it is essential to the health, safety and welfare of the community to amend the Traffic Violations Bureau Ordinance Section.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ALEX, OKLAHOMA:

SECTION 1: Section 11-16 of the Town Code shall be amended and shall read:

A. A Traffic and Municipal Violations Bureau is hereby established as a division of the Office of the Clerk of the Court, to be administered by said Clerk, or by subordinates designated by him or her for that purpose.

B. Persons who are cited for a violation of any of the Traffic or Municipal Ordinances of the Town of Alex, Oklahoma, other than for (a) a second traffic offense within a twelve (12) month period, (b) a driver's license offense, or, (c) and offenses punishable by a fine of more than \$750 may elect to pay a fine in the Traffic Violations Bureau according to the following schedule:


C. The court may adopt further rules to implement this section. Payment of a fine under this section shall constitute a final determination of the case against the defendant. If a defendant who has elected to pay a fine under this section fails to do so prosecution shall proceed under other provisions of this chapter.

Section 2: Emergency Clause

WHEREAS, it being immediately necessary for the preservation of the peace, health and safety of the Town of Alex, Oklahoma and the inhabitants thereof that the provisions of this ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof this ordinance shall take effect and be in full force from and after its passage as provided by law.
